Guidelines for all Participants

1. Loading in and out instructions will be sent on April 10 by email. On Saturday you must be set up by 9am and remain till 7pm! NO EXCEPTIONS
2. Your Displays, equipment and merchandise must fit within the space you pay for (10x12). NO Exceptions (measurements included tongue of trailer). Please send a picture to show your setup.
3. No Vehicles are allowed in the festival area from 9am-7pm on Saturday. No entry after 9am
4. You must supply your own display equipment (table, tent and chairs).
5. If you require electricity, you must furnish your own 110v extension cord. Multiple hook ups that use more amperage than our electrical system can cause a power outage for your space.
6. No water is available, No 220v is available, no exceptions, no Noisy generators.
7. In the event of bad weather, call 919 304-3737. We will send out an email 48 hrs prior.
8. No Alcohol, Drugs, Weapons, or Animals!!!! No Weapons to be sold at Dogwood!
9. You are responsible for your trash. You may not use trash cans on the sidewalks or the streets.
10. Food Vendors must pass the Alamance County Health Department inspection. Alamance County Health Department charges \$95.00 for each inspection. This fee is not included in your space fee charged by MBA and has nothing to do with the MBA. Inability to pay fee or pass inspection will not result in a refund from the MBA. You must contact health department!

The undersigned acknowledges that this waiver shall operate to bar the undersigned from any claim it may have for injury to property or person for any event which may occur during the participation in the Mebane Dogwood Festival including any injury which may arise due to the condition of the streets or sidewalks and the undersigned does hereby further waive and release unto the said Mebane Business Association any such claim or cause of action and agree that he/she shall hold the Mebane Business Association, its officers, agents or employees harmless from any liability arising out of any such act.
